Parade Float Rules

- 1. No one may get on or off the float once it has started down the parade route.
- 2. No dangling legs over the edge of the float. 4. All floats must be of the "pull behind" type on a trailer.
- 3. There must be a responsible adult present if any children are riding or walking with the float
- 4. No real weapons / fire arms allowed, except by law enforcement, on any float entry.
- 5. No smoking or alcoholic beverages on any parade entry at any time before or during the parade. Safety first!
- 6. All floats should have an 8" clearance from the ground.
- 7. The pull vehicle must be able to travel slow enough to avoid stalling.
- 8. Float must be decorated on all four sides.
- 9. No fire or flame-producing devices are allowed on floats.

PARTICIPANT WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I hereby make application for myself and my family members including those who may be minors and or business/club/organization, to voluntarily participate in the Louisiana Forest Festival Parade to take place on April 16, 2022 in Winnfield, LA.
